I, the undersigned property owner, hereby request the Fire Department of the City of Royston to respond to any fire call made by me, or on my behalf during the calendar year indicated above, for the protection of my property located hereinafter designed. Payment of the annual registration fee is herewith; and I further agree to pay to the City of Royston a minimum fee of \$50.00 plus all expense incurred exceeding said \$50.00 within (5) days after said Fire Department has responded to any fire call for me as aforesaid.

I understand that the City of Royston in no way warrants the effectiveness or results of the services that it may render under this agreement, and that said City assumes no financial liability whatever by virtue of this agreement and by virtue of the services it may render hereunder, said City being expressly relieved from any claim of damage or financial liability. I understand that said City assumes no responsibility whatever in this connection except upon call from me or respond with its fire fighting equipment in and effort to protect my property from destruction or damages by fire with reasonable diligence and efficiency under any given circumstances, the Fire Chief using his total discretion as to what equipment shall respond to the fire.

In the event the circumstances beyond the control of said City should make it impossible for said fire fighting equipment to respond to a call made by me, a refund of the current year's registration fee by said City shall operate as a full discharge and release of all its obligations to me.

I, the property owner, grant permission to the City to respond to a fire call whether another party or I call and I will be liable for the set fees.
